Regulatory framework



- **Changes in FANC law** → Scope of the register, access rights, , data sources, ...

- **Changes in the RD of 20/07/2001 (RD-BSS)** → Who should do what?

- **Separate RD** → Detailed contents of the register, protection/security of personal data

- **FANC technical regulation + annexes** → How to deal with the exposure register?




Access rights

- Employers (operators, outside undertakings) → data of the workers they employ
- Workers → their own data
- Other RP actors: health physics experts, **approved occupational physicians**, approved dosimetry services → data of the workers they follow

Roles and responsibilities

- **The operator is responsible for the dose transfer** to the register:
 - 1 time/year, deadline on 30th of June
 - from the date of entry into force of the regulatory framework, the transfer frequency will gradually increase towards the monitoring frequency
- **Transfers under supervision of the health physics expert** (by default, of the prevention advisor).
- **Transfer can be performed in practice by the internal/external person/entity designated by the operator** (ex: health physics department, ICT department, dosimetry service, ...)




Roles and responsibilities

- **No validation is required from the occupational physician** but his/her role vs dosimetry is clarified in the revision of the RD of July 2001 (art 24):
 - Evaluation and interpretation of the doses from the health point of view
 - Recording of the doses in the health files
 - Regular monitoring of the doses for rapid reaction in case of high/abnormal doses (eg: proposing dose constraints)
 - By using the exposure register (but transfer frequency for now only annual!)
 - By using the dose records provided by the health physics department (regular communication will always be required)

Access to the NDR-Application

- NDR-App is on the **FANC Data Exchange Platform (DXP)** designed for interaction between FANC and business partners -> <https://dpx.fanc.be>
- To access the NDR-App ([Access guide](#)):
 - 1) NDR roles should previously be received from companies that employ your workers
 - NDR roles assigned using the CSAM platform (<https://www.csam.be> & [guide step by step](#))
 - Legal representative (CEO)
 - ↳ Chief Access Manager
 - ↳ Access Manager (domain of **Home Affairs**)
 - ↳ NDR roles by using the [eGov Role Management \(RMA\)](#) module:
FANC Worker Dose - Data Management
FANC Worker Dose - Consult
 - How to receive your NDR roles for a given company:
 - ✓ You belong to the internal medical service -> address to your access manager (who? -> info via HR/Accounting services).
 - ✓ You belong to an external medical service -> address to your management -> he/she requests the access manager of the company to grant you the roles
- 2) Connect to DXP using CSAM authentication module (e-ID or ItsMe)
- 3) Select the NDR-App
- 4) Consult the data of your workers (-> see demo)
